3. APPROVAL OF CONTRACT - HIGHLINE CANAL PATH LIGHTING DESIGN: Council will consider and may act to award contract (C2021-14A) to the Town Engineer, Dibble Engineering (Dibble), in the amount of \$59,424.00, to provide engineering, design, and project management services to prepare final construction and clearance documents for the Highline Canal Recreational Path Lighting Project. This project that will be advertised and administered by the Arizona Department of Transportation (ADOT). The purpose of this project is to provide a safe, efficient, improved, and cost-effective pedestrian path lighting system. Funding for this contract is available through the approved fiscal year 2022/2023 Grant Fund budget. Council may provide direction to the Town Manager / Clerk.

**4. Funding for this contract is available through the adopted Fiscal Year 2023 Budget Tohono O'odham Grant Fund and COVID-19 Pascua Yaqui Tribe Relief Funds.
