APPROVAL of CONTRACT: Council will consider and may approve a Design Services Contract and a Municipal Aesthetics Funding Agreement between Salt River Project Agricultural Improvement and Power District (SRP) and the Town of Guadalupe for the design of electrical facilities for the conversion of overhead powers lines to underground power lines from Calle Sahuaro to Calle Azteca along Calle Guadalupe and direct the Town Manager to sign all necessary documents in furtherance of this contract.
