- G. DISCUSSION AND POSSIBLE ACTION ITEMS:
 1. **SUMMER YOUTH LEADERSHIP PROGRAM:** Council will receive a presentation from Community Action Program (CAP) staff regarding a proposed summer Youth Leadership Program. The proposed week long program, from June 3rd through June 7th, will offer Guadalupe High school students with the opportunity to learn how to address challenges in their community through advocacy training, engaging with Town staff to learn the inner workings of municipal government, and learn from community experts to develop a presentation on their own public policy topics of interest. Town of Guadalupe high school age students are eligible for the program and is limited to twelve participants. Applications will be available from April 1st through April 30th. The approximate cost is \$1500 and is available through the CAP budget. Council may provide direction to the Town Manager / Clerk.
 2. **2024 12% REVENUE SHARING GRANT PROGRAM:** Council will receive recommendations for sixteen 12% revenue sharing (gaming) grant submittals for the 2024 grant cycle from Town Manager / Clerk. The sixteen recommended grant submittals to five entities total \$1,186,000 for the 2024 grant cycle and would provide funding for needed repairs, equipment, and services. The resolutions to the individual entities follow as agenda items 3 through 7. Council may provide direction to the Town Manager / Clerk.

3. **AK-CHIN INDIAN COMMUNITY 12% REVENUE SHARING GRANT (RESOLUTION NO. R2024.06):** Council will consider and may adopt Resolution No. R2024.06 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$210,000 from the Ak-Chin Indian Community to fund a shade structure for fire department vehicles, a command/community service vehicle for the Guadalupe fire department, and cultural event programming; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application. Council may provide direction to the Town Manager / Clerk.

4. **FORT MCDOWELL YAVAPAI NATION 12% REVENUE SHARING GRANT (RESOLUTION NO. R2024.07):** Council will consider and may adopt Resolution No. R2024.07 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$187,000 from the Fort McDowell Yavapai Nation to fund firefighter replacement turnout gear, public works maintenance yard warehouse/restroom/tool shed renovation, and public works dump trucks; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application. Council may provide direction to the Town Manager / Clerk.

5. **GILA RIVER INDIAN COMMUNITY 12% REVENUE SHARING GRANT (RESOLUTION NO. R2024.08):** Council will consider and may adopt Resolution No. R2024.08 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$207,000 from the Gila River Indian Community to fund a community action program workforce development program, public works maintenance yard vehicle shade structure, and a senior center entryway/patio remodel; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application. Council may provide direction to the Town Manager / Clerk.

6. **PASCUA YAQUI TRIBE 12% REVENUE SHARING GRANT (RESOLUTION NO. R2024.09):** Council will consider and may adopt Resolution No. R2024.09 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$424,000 from the Pascua Yaqui Tribe to fund the renovation of the Guadalupe fire station truck bay flooring, doors, and roof; renovation of Biehn park restrooms, ballpark, and playground; installation of flagpoles, renovation of a ramada, and replacement of gates at the Guadalupe cemetery; and, public safety services for cultural and community events; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application. Council may provide direction to the Town Manager / Clerk.

7. **TOHONO O'ODHAM NATION 12% REVENUE SHARING GRANT (RESOLUTION NO. R2024.10):** Council will consider and may adopt Resolution No. R2024.10 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$158,000 from the Tohono O'odham Nation to fund the purchase of an event utility vehicle, replacement kitchen equipment and appliances for the Senior Center and Community Action Program family utility assistance; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application. Council may provide direction to the Town Manager / Clerk.

8. **TRIBAL REVENUE SHARING SUPPORT LETTER REQUEST:** Council will consider and may take action to approve a support letter for inclusion with Bella Estrella's revenue sharing application to the Gila River Indian Community. Bella Estrella's is requesting \$50,000 for supplies to teach transferable life skills to adolescents and their caregivers. Council may provide direction to the Town Manager / Clerk.

The purpose of this report is to provide brief information regarding each agenda item.

G1. SUMMER YOUTH LEADERSHIP PROGRAM (PAGES 7 – 10): Council will receive a presentation from Community Action Program (CAP) staff regarding a proposed summer Youth Leadership Program. The proposed weeklong program, from June 3 through June 7, will offer Guadalupe High school students with the opportunity to learn how to address challenges in their community through advocacy training, engaging with Town staff to learn the inner workings of municipal government, and learn from community experts to develop a presentation on their own public policy topics of interest. Town of Guadalupe high school age students are eligible for the program, is limited to 12 participants. Applications will be available from April 1 through April 30. The estimated cost to operate this program is \$1500 and is available through the CAP budget. Council may provide direction to the Town Manager / Clerk.

G2. 2024 12% REVENUE SHARING GRANT PROGRAM (PAGES 11 – 23): Council will receive recommendations for sixteen 12% revenue sharing (gaming) grant submittals for the 2024 grant cycle from Town Manager / Clerk. The 16 sixteen recommended grant submittals to five entities total \$1,186,000 for the 2024 grant cycle address service needs, replacing aging and worn equipment, and renovating and repairing deteriorating Town facilities in 7 service areas:

G3. AK-CHIN INDIAN COMMUNITY GAMING GRANT (RESOLUTION NO. R2024.06) (PAGE 19): Council will consider and may adopt Resolution No. R2024.06 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$210,000 from the Ak-Chin Indian Community to fund a shade structure for fire department vehicles, a command/community service vehicle for the Guadalupe fire department, and cultural event programming; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application

G4. FORT MCDOWELL YAVAPAI NATION GAMING GRANT (RESOLUTION NO. R2024.07) (PAGE 20): Council will consider and may adopt Resolution No. R2024.07 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$187,000 from the Fort McDowell Yavapai Nation to fund firefighter replacement turnout gear, public works maintenance yard warehouse/restroom/tool shed renovation, and public works dump trucks; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application.

G5. GILA RIVER INDIAN COMMUNITY GAMING GRANT (RESOLUTION NO. R2024.08) (PAGE 21): Council will consider and may adopt Resolution No. R2024.08 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$207,000 from the Gila River Indian Community to fund a community action program workforce development program, public works maintenance yard vehicle shade structure, and a senior center entryway/patio remodel; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application.

G6. PASCUA YAQUI TRIBE GAMING GRANT (RESOLUTION NO. R2024.09) (PAGE 22): Council will consider and may adopt Resolution No. R2024.09 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$424,000 from the Pascua Yaqui Tribe to fund the renovation of the Guadalupe fire station truck bay flooring, doors, and roof; renovation of Biehn park restrooms, ballpark, and playground; installation of flagpoles, renovation of a ramada, and replacement of gates at the Guadalupe cemetery; and, public safety services for cultural and community events; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application.

G7. TOHONO O'ODHAM NATION GAMING GRANT (RESOLUTION NO. R2024.10) (PAGE 23): Council will consider and may adopt Resolution No. R2024.10 authorizing the submittal of an application for a 12% revenue sharing (gaming) grant of \$158,000 from the Tohono O'odham Nation to fund the purchase of an event utility vehicle, replacement kitchen equipment and appliances for the senior center and community action program family utility assistance; and, direct the Mayor, or designee, to sign all necessary documents in furtherance of this grant application.

G8. TRIBAL REVENUE SHARING SUPPORT LETTER REQUEST (PAGES 24 – 26): Council will consider and may take action to approve a support letter for inclusion with Bella Estrella's revenue sharing application to the Gila River Indian Community of \$50,000.

At the October 28, 2021, Regular Council Meeting, the Council approved a support letter request application process for non-profit organizations applying for Tribal revenue sharing (also referred to as gaming) grants. The Town has received a request for a support letter from Bella Estrella to include with their grant application to the Gila River Indian Community. Bella Estrella is requesting \$50,000 from the Gila River Indian Community for supplies to teach transferable life skills to adolescents and their caregivers. Bella Estrella's support letter request is attached. The Gila River Indian Community submittal deadline for grant applications is April 1, 2024.

Summer Leadership Development Program Proposal

Description:

The Town of Guadalupe's Community Action Program (CAP) will be hosting a summer youth leadership development program to target Guadalupe high school students who are interested in civic engagement. This program is designed to help high school students identify challenges in their community and help equip them with the tools necessary to make effective change. During this weeklong program participants will have the opportunity to engage with Town staff to learn the inner workings of municipal government, learn from community experts, and develop a presentation on their own public policy topics of interest.

Program Components:

- Public Policy Presentations
- Day of Service
- Guest speakers who work in Public Service

Target Audience:

The target audience for this program would be a maximum of 12 Guadalupe High School students. Students will be split into 4 groups of 3 and tasked with identifying a public policy issue or challenge in their community that they want to come up with effective solutions for. Students will be recruited from the various Tempe Union High School District and the surrounding schools where Guadalupe Freshmen – Seniors attend.

**Students will apply and potentially be interviewed for this program depending on the number of applicants.*

Program Dates:

June 3rd – June 7th (2nd week of summer break)

Program Agenda:

Day 1: Introduction and issue selection

- Welcome and program overview.
- Discuss the importance of leadership in addressing community issues.
- Introduce the concept of public policy and its impact on communities. (Pastor Center ASU)
- Brainstorm potential public policy issues affecting the community.
- Students select an issue they are passionate about and form teams.
- Meet & Greet: Mayor & Council / Town Manager

Day 2: Day of Service/ Research and Analysis

- Participate in potential service project (Food Bank, Park Clean-up, etc.)
- Provide resources and guidance on conducting research related to the chosen issue (e.g. statistics, case studies, expert opinions)
- Facilitate discussions on the root causes and stakeholders involved in the issue.
- Encourage critical thinking and analysis of potential solutions.

- Teams gather information and data to inform their presentations.
- Potentially have guest speakers from the AZ House of Representatives (Lorena Austin & Cesar Aguilar, Marcelino Quinonez)

Day 3: Strategy Development

- Introduce strategic planning concepts and frameworks.
- Help teams identify goals, objectives, and action steps to address the chosen issue.
- Provide feedback and support as teams refine their approaches (Bring in experts to provide feedback)
- Potentially have guest speakers from the AZ House of Representatives (Lorena Austin & Cesar Aguilar, Marcelino Quinonez)

Day 4: Presentation Preparation

- Discuss effective presentation skills, including organization, storytelling, and visual aids.
- Assist teams in structuring their presentations (e.g. introduction, problem analysis, proposed solutions, implementation plan)
- Conduct practice presentations and provide constructive feedback.
- Teams finalize their presentations and prepare visual materials.

Day 5: Presentation Day

- Teams present findings and proposals to peers, instructors, and community members. High school students will be encouraged to invite family, friends, and loved ones to attend presentation day.
- Encourage audience engagement through Q&A sessions.
- Facilitate constructive feedback and discussion following each presentation.
- Celebrate achievement and acknowledge the impact of student-led initiatives.

Post-Program:

- Gather feedback from students to assess the program's effectiveness and identify areas for improvement.
- Encourage students to implement their proposals in the community with support from the CAP office.
- Provide opportunities for reflection and ongoing learning through follow-up sessions or mentorship.
- Evaluate Summer Leadership Program for future participants.

- Session times (8 AM – 12 PM or 9 AM – 3 PM)
- Food for participants if the program is running throughout the day.
- Where can presentations be held (Potentially MPR)

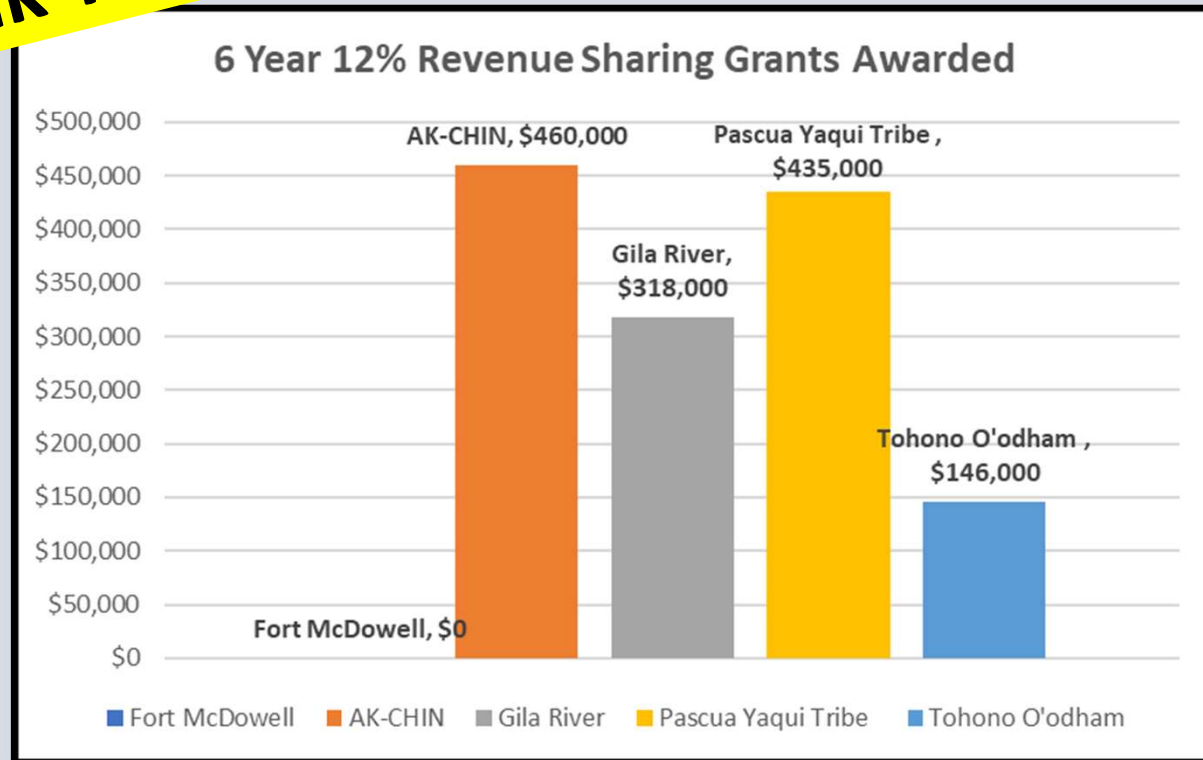

- Organization must meet the criteria for the specific grant for which they are applying.
- Organization must demonstrate how the program will benefit the Guadalupe community.

DEADLINE:

Requests for letters of support must be received by the Town of Guadalupe *no less than 30 days prior to the grant application submittal deadline.* For example:
