1. Board of Adjustments – Public Hearing – Case # V06-15.A, Request for a variance (15') allowing for zero (0) feet street side yard setback (15' required – R1-6). Danny & Lydia Gomez, 8002 S. Calle Moctezuma.

The applicant, Mr. Gomez, requested approval since he obtained a building permit and also because he was led to believe he could build the porch with zero side yard setback because his lot was a corner lot.

Mr. David Hernandez stated he received notice of a public hearing and was present to say he does not object to zero side yard setback since it was a corner lot.

David Ledyard, Town Attorney, said in review of the plat it was found there is a parcel along the north side of Mr. Gomez's parcel. It is not a corner / street side lot. He advise council to re-advertise the hearing for a conditional/special use permit.
