Council will review the recommendation of the Guadalupe Judicial Advisory Board for a Town Magistrate and may take action to accept the recommendation and approve a contract with Fidelis Garcia to provide contract services to act as the Presiding Magistrate of the Guadalupe Court for a two year term.

- 5. Possible approval of the FY2018 tentative town budget which will establish the maximum amount of expenditure for the town for the upcoming fiscal year at \$12,760,999 and setting a date for a public hearing on the budget.
