To allow a body shop at this location will require a conditional use permit. The applicant is also requesting a variance to the setback requirement and to change zoning from C1 to C2.

Council will consider approving the application for Ali Alsultani for a variance to the setback requirement for the location, change zoning codes for the location from C1 to C2 and issuance of a conditional use permit so that he can operate a body shop and auto repair shop at 8207 S. Avenida del Yaqui.

the HURF Fund to pay for ADEQ and flooding projects.
