Minutes Town Council Regular Meeting October 11, 2018

Minutes of the Guadalupe Town Council Regular Meeting held on Thursday, October 11, 2018, at 6:00 P.M., at Guadalupe Town Hall, 9241 South Avenida del Yaqui, Guadalupe, Arizona, in the Council Chambers.

A. CALL TO ORDER

Vice Mayor Cota called the meeting to order at 6:00 P.M.

- G. DISCUSSION AND POSSIBLE ACTION ITEMS:
- **1. PUBLIC HEARING:** Held a public hearing for proposed changes to the Town of Guadalupe Tax Code pursuant to A.R.S. § 42-6053. The proposed changes relating to the Transaction Privilege Tax will adopt the 2012-2014 amendments to the Tax Code of the Town of Guadalupe by reference; providing for severability and establishing effective dates. (*Note: this item is related to agenda items G2 and G3*)

MODEL CITY TAX CODE 2012-2014 AMENDMENTS TO THE TOWN OF GUADALUPE TAX CODE (ORDINANCE NO. O2018.02)**: Councilmembers reviewed Model City Tax Code 2012-2014 Amendments, Sections 1 through 16, to amend and include in the Town of Guadalupe Tax Code, and directed staff to move forward with implementation. **ORDINANCE NO. O2018.02** adopts the Model City Tax Code 2012-2014 Amendments, by reference, to Resolution No. R2018.21 (agenda item G3). (*Note: this item is related to agenda items G1 and G3*)

Jeff Kulaga, Town Manager / Clerk, stated that at the September 27, 2018, Regular Council Meeting, staff briefed the Town Council regarding the Model City Tax Code (MCTC) 2012-2014 Amendments to the Town of Guadalupe Tax Code. Adoption of the proposed ordinance, as well as Resolution No. R2018.21 (agenda item G3), would bring the Town of Guadalupe Tax Code into conformance with the MCTC. From a financial standpoint, the impacts of the 2012-2014 Amendments are immaterial and negligible to the Town.

Motion by Councilmember Sánchez to approve agenda item G2; second by Councilmember Osuna. Motion passed unanimously 5-0.

3. MODEL CITY TAX CODE 2012-2014 AMENDMENTS TO THE TOWN OF GUADALUPE TAX CODE (RESOLUTION NO. R2018.21): Councilmembers adopted **RESOLUTION NO. R2018.21** related to the Model City Tax Code 2012-2014 Amendments, Sections 1 through 16, and directed staff to move forward with implementation. The Amendments will be incorporated into the Town of Guadalupe Tax Code. (*Note: this item is related to agenda items G1 and G2*)

Jeff Kulaga, Town Manager / Clerk, stated that adoption of Ordinance No. O2018.02 (agenda item G2), as well as the proposed resolution would bring the Town of Guadalupe Tax Code into conformance with the Model City Tax Code.

Motion by Councilmember Osuna to approve agenda item G3; second by Councilmember Valenzuela. Motion passed unanimously 5-0.

4. TOWN OF GUADALUPE FIRE BOARD OF THE PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM APPOINTMENTS: Councilmembers discussed appointing and reappointing members to the Town of Guadalupe Fire Board of the Public Safety Personnel Retirement System pursuant to A.R.S. § 38-847. The purpose of the Board is to administer the Public Safety Personnel Retirement System for Guadalupe Fire services. The Town of Guadalupe Fire Board of the Public Safety Personnel Retirement System is composed of five members consisting of the Mayor, or a designee of the Mayor (as chair), two members elected from the Guadalupe Fire Department, and two citizens of Guadalupe. The citizen members of the Board are appointed by the Mayor with the approval of the Town Council. The Board meets a minimum of twice a year in the Guadalupe Town Hall, 9241 S. Avenida del Yaqui, Museum Room, Guadalupe, AZ. Members for consideration and possible appointment are: Jeff Kulaga, Town Manager as Chair; two citizen representatives; and, appointing Dennis Dominguez and Alan Romania as Guadalupe Fire Department representatives.

Jeff Kulaga, Town Manager / Clerk, stated that the Town has hired a new firefighter, George Fleming. Mr. Fleming is scheduled to attend training on Monday, October 15, 2018. Per state statute, there must be a local fire board that makes a recommendation to Public Safety Personnel Retirement System (PSPRS) to add Mr. Fleming to the public safety retirement system. Mr. Kulaga noted that the previous Town of Guadalupe PSPRS board disbanded in 2014. The proposed Council action is to re-establish the local board in order to comply with state statues. If approved, a PSPRS meeting will be held on Friday, October 12, 2018.

The purpose of this report is to provide brief information regarding agenda items for the Regular Council meeting.

5:00 PM Regular Council Agenda Items:

- **G1.** Council may vote to go into Executive Session to review the Town Manager / Clerk's performance and contract.
- **G2.** Council may vote to renew the contract with Jeff Kulaga to serve as Town Manager / Clerk for another one year period. Terms and conditions of the 2018 contract are generally similar to the original 2017 contract approved on September 28, 2017. The proposed 2018 contract is attached.

EMPLOYMENT AGREEMENT OF TOWNMANAGER/CLERK

THIS AGREEMENT (this "Agreement") is executed by and between the Town of Guadalupe, an Arizona municipal corporation, (the "Town") and Mr. Jeff Kulaga ("Kulaga") as of this October 22, 2018.

- 1. The Town wishes to reappoint Kulaga as Town Manager/Town Clerk and Kulaga is willing to accept continued employment in this combined position and perform such duties as are required.
- 2. The Town shall extend the employment opportunity to Kulaga and offer the following salary, and other terms as follows:
 - (a) Salary Maintain current annual salary amount as approved on September 28, 2017 to be paid in biweekly increments in accord with the Towns normal payroll practices.
 - (b) This position is an exempt management position and Kulaga will use his best efforts to fulfill the duties of the Town Manager and Clerk.
 - (c) Kulaga will receive all of the normal benefits and opportunities afforded to a Guadalupe management level exempt employee.
 - (d) The term of this agreement will be for one year beginning October 22, 2018 however, the term may be extended upon mutual agreement of the parties.
 - (e) The Council is aware that Kulaga occasionally is a guest lecturer, student mentor and/or speaker and may need to leave early, or extend a lunch hour. Such activities are permitted so long as they do not unnecessarily interfere with his duties at the Town.
 - (f) In the event the Council should terminate this contract without cause, Kulaga shall be entitled to severance pay equal to his base pay for three months, accrued PTO time, deferred compensation, and paid holidays accrued during the three-month severance period and the Town shall pay the cost to continue health insurance for Kulaga and all dependents and life insurance during the three-month severance period.

Council may terminate this contract at any time for cause including willful misconduct, fraud, corruption, moral turpitude, or refusal or failure to perform in breach of this agreement. In the event this agreement is terminated involuntarily for cause or Kulaga resigns, the Town will not have to pay a severance package.

(g) In the event Kulaga wishes to resign, he will give the Town not less than thirty (30) days' notice.

- 3. This agreement serves as the formal employment agreement between the Town and Kulaga and is the full and complete agreement of the parties and will be treated as such.
- 4. A.R.S. §38-511 concerning conflict of interest applies to this agreement.
- 5. The parties agree to work together in good faith in the performance of this agreement.
- 6. In the event of a breach of this agreement, the nonbreaching party is entitled to their reasonable attorney fees and costs resulting from the breach.
