Application for a Liquor License by Arutiun Harry Kirakosian for a convenience store located at 9210 S. Avenida del Yaqui formerly the Farmer's Market. The purpose of this public hearing is to allow the Town Council to receive input from the public concerning the request for a liquor license at this location. After the public hearing, the Council will make a decision to either recommend to the State Liquor Board the issuance of a license or to deny the request.

The R-2 zone requires a front set back of 20 feet and a side yard setback of 15 feet.
