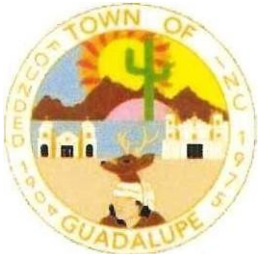

3. **PUBLIC HEARING:** Request for a variance to reduce the required front yard setback and a variance to reduce the street side setback for the Patricio Duenas residence located at 5803 E. Calle San Angelo in the R-2, single family residential district. Mr. Duenas desires to construct a new home on the lot and is requesting approval of two variances. The first variance is to reduce the required front yard setback from 25 to 20 feet. The second variance is to reduce the required street side setback from 20 to 15 feet.

4. Council will consider and may take action to approve or deny the two requested variances for the Patricio Duenas residence located at 5803 E. Calle San Angelo.
