## D. DISCUSSION / STUDY SESSION:

1. Maricopa County Sheriff's Office - November & December, 2009, Activity Report.

No questions or discussion regarding the activity reports.

2. Maricopa County Sheriff's Office - Law Enforcement Services.

Mr. Hernandez stated the annual amount for cost of law enforcement for service for FY2011 starting July 1, 2010 is \$1,185,999 less approximately \$30,000 than 2009/2010 (\$1,216,368.) Maricopa County Sheriffs had decreases that resulted in decrease to the town's contract in the following areas; benefits from 30.73% to 29.93%, uniform allowance no longer budgeted, and vehicle depreciation based on mileage.

3. Maricopa County Human Services - Community Action Programs (CAP Services).

Maricopa County has announced the Invitation to Negotiate for CAP Services. If the town is interested in submitting a proposal to continue to provide CAP Services to the community the proposal must be submitted by March 26 to County.

4. Curfew for Juveniles.

It was the consensus of the council to change curfew hours and instructed legal counsel to prepare the ordinance for council's action.
