## D. DISCUSSION / STUDY SESSION.

1. Redistricting Fundamentals 2011 - Congressional Assistant, Jose Rivas.

Jose Rivera, Congressional Staff for U.S. Congressman Ed Pastor, provided a power point presentation regarding the purpose and process of redrawing district boundaries - redistricting. He covered the federal guidelines for redistricting requiring the one person one vote mandate and contiguity requiring that a district be a single, unbroken shape taking under consideration natural

boundaries or dividers. The Independent Redistricting Commission's mission is to administer the fair and balanced redistricting of the Congressional and Legislative districts for Arizona. Redistricting plans shall be approved by US Justice Department before implementation. Jose stated it is crucial the town be proactive and encourage the community to be involved and have representation at the commission meetings. He urge council prepare a testimony or statement and be prepare to deliberate when maps are drafted. The testimony should include a map, qualitative data - common and familiarities within area, quantitative demographic data of the community, relationship and familiarities around the community, common public service and facility usage.

Bill Hernandez, town manager, stated although there are many common usage of public service facilities with the city of Tempe, but it is highly unlikely a republican would advocate for Guadalupe which is democratic.
