- b) The Council may give directions to the Town attorney and the Town Manager concerning possible negotiations concerning the sale, purchase, or lease of real and personal property and/or contractual negotiations relating to fire services-ARS 38-431.03(A)3,4,7.

As drafted the Council would go into an executive session for the limited purpose of discussing the fire issues and then would go back out into the open session to discuss the budget issues.
