### MINUTES OF THE REGULAR MEETING OF THE TOWN OF GUADALUPE COUNCIL

A public meeting of the Town of Guadalupe Council was held on **THURSDAY**, **JULY 26**, **2012**, **AT 7:00 P.M.**, 9241 South Avenida del Yaqui, Guadalupe, Arizona, in the Council Chambers. The following members of council were present:

E. CALL TO THE PUBLIC. An opportunity is provided to the public to address the Council on items that are not on the agenda or included on the consent agenda. Citizens are requested not to exceed a three minute time period for their comments. Please note that those wishing to comment on agenda items posted for action will be provided the opportunity at the time the item is heard.

Rebecca Jimenez, resident (former councilmember/Mayor) stated someone had left a stack of copies

of a letter listing concerns regarding council and town business. The letter said last year council raped the sewer budget to balance the budget and also that the Mayor had moved out of town as of

March. She said town paid for room and board for a conference not related to town business

attended by the Mayor and other members of council. She also said the letter accuses the Mayor of

having an affair with a married man by the name of William Mabry. She said if it were another city or town an ethics committee would be formed to investigate the accusations. Mayor Solarez told her time was up and to stop her comments.

F. DISCUSSION AND POSSIBLE ACTION ITEMS:

1. Kacy S. Tomason, Ward Traditional Academy Principal, Fees College Preparatory.

Ms. Tomason introduced staff, Maurine Skully and Enrique Ruiz addressing council her wishes to introduce her staff to the community.

2. Yolanda L. Waggoner, Asist Principal and Principal Rey of Frank School Elementary.

Ms. Waggoner and Mr. Cruz addressed council pledging to continue to be part of the life of Guadalupe and the academic process of the students.

3. Tempe District Elementary Schools, Superintendent Christine Busch.

Mr. Cruz stated Superintendent Busch extended her greetings and her apologies for her absence. He said he looks forward to collaboration with staff and the community on behalf of the students of the community. Superintendent will at another time address the Mayor and Council.

4. Budget Fiscal Year 2012-13 - Public Hearing.

Rebecca Jimenez stated former Mayor Bernie Jimenez stayed clear from taking from other funds to balance the budget. She said last June there was one million dollars in the enterprise sewer budget which she understood not to be restricted. She also said when she was on council the town manager was hired with a salary of \$40,000 and now he's at \$70,000. Ms. Jimenez said she reviewed the budget provided on the town's website.

Mr. Hernandez said there has been no salary increases for staff since he's been on board and also that enterprise funds is set up setting aside monies to be used when needed such as for sewer and sanitation. Enterprise funds are not restricted.

Councilmember Andrew asked about tabling the budget until the next meeting because he does not understand the enterprise and sewer fund. He would like to schedule meeting with Robert Thaxton and Bill Hernandez..

Mayor A. Yolanda Solarez said she lives on Calle Saguaro and that Ms. Jimenez shows up and

makes statements without providing proof and or facts.

Vice Mayor Laura Valencia asked if council could vote on the budget and revisit the budget. Bill Hernandez replied that council may without changing the final budget number.

Councilmember Saturnino Flores suggested voting on the budget and those members of council

who have questions on the budget schedule a meeting with the town manager and staff.

Mr. Ledyard, town attorney, reminded council that council will be voting to possibly cancel the

regular meetings in August.

Mr. Hernandez said that the town audit has started and will be presented to council in October or November.

There being no more comments from the audience. . .
