- Mayor A. Yolanda Solarez announced that the retreat could not be realized but will reschedule as soon as possible. She spoke of the fatal tragedies that struck the community. Also mentioned CDAC and the process and competitiveness to be awarded when other

Bill Hernandez said that Guadalupe is a victim of its own success. The town's projects are very successful and other cities and towns are jealous because they have been unable to compete with Guadalupe. Because CDAC has taken other cities and towns concerns they are looking into changing the policy or requirements to get a project funded. Bill Hernandez said the town has the ability to appeal to HUD regarding housing rules. He also said SCTAP funds are open for additional funds and SRP aesthetics funds are targeted for under grounding of the canal and also for street lighting.
