- C. INVOCATION by Mayor A. Yolanda Solarez followed by the PLEDGE OF ALLEGIANCE.

  - Mrs. Antonia Campoy apologized for the misunderstanding regarding display of the Inside Out Photo project. She had understood it would be okay to put the photos on the G.U.A.D. building. She said members of the community assisted in putting up the pictures. She said a couple of the Photos were detaching and they will be going back to add paste. She also said it was up to Council how long the photos will be displayed.

# F. DISCUSSION AND POSSIBLE ACTION ITEMS:

1. Guadalupe Court - credit card payment option.

Town Court would like to accept payment by debit and credit cards which may increase collections. Chase bank will provide the terminal costing the court \$300 to be paid from court enhancements funds. The service charge of 3% will be charged as a bank charge. Mr. Hernandez said upon council's approval the payment will be implemented by the court and possibly later in other departments.

2. Construction Management Contract with Tri-Core Engineering for Calle Vauo Nawi Pavement Improvement Project #5047.0034

MOVED by Mayor A. Yolanda Solarez to approve the contract with Tri-Core Engineering for construction management for Calle Vauo Nawi Pavement project. SECONDED by Councilmember Joe Sanchez.

3. Award of Bid for the street sweeper.

The Town of Guadalupe was awarded \$152,400 through MAG for the purchase of a street sweeper.

MOVED by Mayor A. Yolanda Solarez to award the bid to Challenger Manufacturing for the purchase of a new 2010 Isuzu street sweeper. SECONDED by Councilmember Joe Sanchez.

4. Sprint Communications Company L.P. - Fiber Optics Communication System License.

Discussed in the previous special meeting.

MOVED by Mayor A. Yolanda Solarez to approve the Fiber Optics Communication System License for Sprint Communications a period of five (5) years from November 10, 2011 through November 9, 2016, at \$2.00 per linear foot annually, totaling \$60,000. SECONDED by Councilmember Joe Sanchez.

Regular Meeting October 13, 2011 5. Best Western Hotel - Council may take action to allow a one time credit (\$3350) on the hotel's bed tax payment.

Bill Hernandez stated when council adopted the 1% sales tax the league informed the town that the 1% increase did not apply to hotels which was conveyed to Best Western who then continued to charge 3% sales tax. Recently Best Western was contacted by Department of Revenue that the 1% increase did apply to hotels and Best Western is responsible for the underpayment. At Best Western's request Mr. Hernandez recommends the town credit the 1% (\$3350.02) for the months of July, August and portion of September on their next bed tax payment.

MOVED by Mayor A. Yolanda Solarez to approve a one time credit of \$3350.02 to Best Western Hotel on their next bed tax payment. SECONDED by Vice Mayor Laura Valencia.

6. Dia de Guadalupe event.

It was the consensus of the Mayor and Council to hold Dia de Guadalupe celebration on February 4, 2012, Incorporation Day, and for the Mercado Committee to plan and coordinate the event.

7. Approval of Claims: Check Registers for the month of August, 2011.

Councilmember Joe Sanchez asked for clarification on payment issued to Western Technologies for lead paint testing in the amount of \$700. He said testing kits can be purchased for \$30.

Mr. Hernandez replied using the contractor a certificate of testing certifying results is issued. He said the company used the same kit.

MOVED by Mayor A. Yolanda Solarez to approve the check register for the month of August. SECONDED by Councilmember Joe Sanchez.

8. Community Development Advisory Committee - Loyalty Oath of Office - Mayor Yolanda Solarez shall take and subscribe the Loyalty Oath of Alternate Representative to CDAC.
